

# X-ray Registrant Verification System

## E-PAYMENTS GUIDE

### Important Notices

*It is highly suggested that registrants gather all data before entering it into the X-ray Registrant Verification System. Registrants will receive a warning after 25 minutes of inactivity. Data will be lost if the time is not extended another 30 minutes. The Equipment tab can be saved as a draft by clicking “Save As Draft” on the bottom of the tab. The draft will save for 72 hours.*

*Registrants who want to pay their x-ray registrations by e-check or credit card must complete their verification in the X-ray Registrant Verification System. The ability to make e-payments will not be available for registrants who have not completed their data verification.*

### E-Payment Enhancements

The E-Payment project includes several enhancements to the X-ray Registrant Verification System. You do not need to mail registration forms or fees for the enhancements below:

1. Annual Registration annual data review process.
2. Annual Registration online payments.
3. Additional Registration process and online payments.
4. Replacement process with no payment due.

### Conduct Annual Data Review

Registrants with an Annual Registration due must conduct an annual data review in the X-ray Registrant Verification System before they can pay their invoice online. The system will time-out after 30 minutes of inactivity, so be sure to gather all necessary documentation to complete your review.

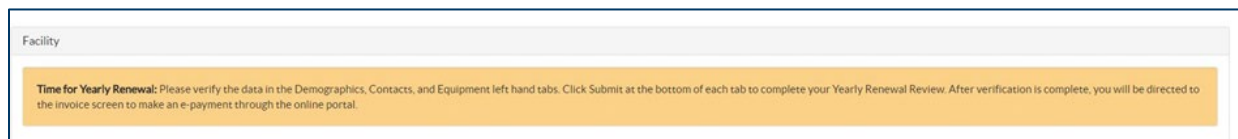
All three tabs on the left-hand side of the screen, Demographics, Contacts, and Equipment must be reviewed before a payment can be made. To complete this review, follow the steps below:

1. Login to the online system at [X-ray Registration System](https://xray.web.health.state.mn.us/) (<https://xray.web.health.state.mn.us/>).

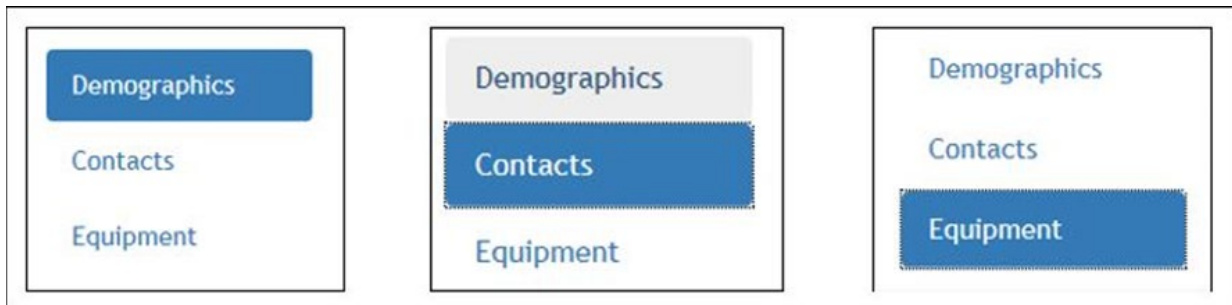

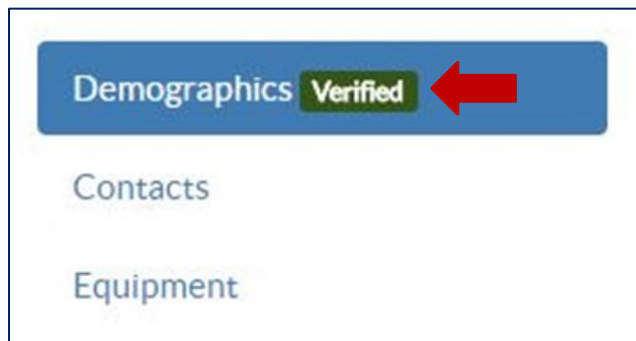
2. Enter your facility Username and Password. If you do not remember your username, contact [health.xray@state.mn.us](mailto:health.xray@state.mn.us). If you do not remember your password, click on Forgot Password, and the system will send you an email.
3. After you click on "view", you will see a "Time for Yearly Renewal" message at the top of the screen.



4. Verify the data on the Demographics tab. Make changes as needed to the data including adding any new equipment, and then click the Submit button at the bottom of the screen.



5. When the Submit button is clicked, you will see the word "Verified" on the tab completed.

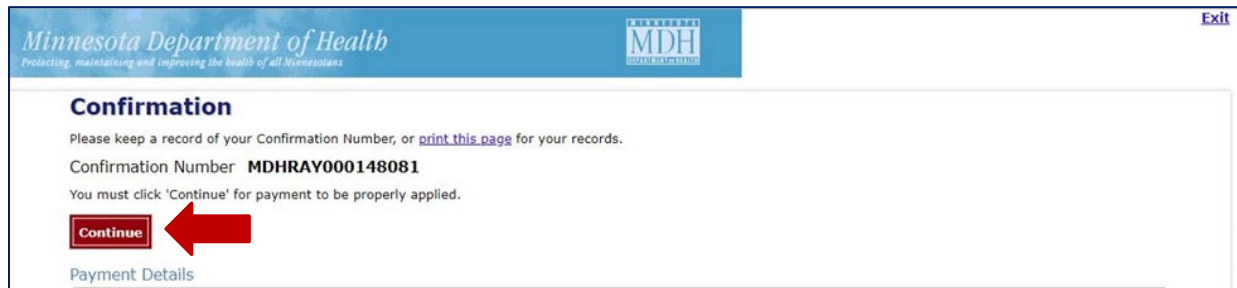


6. If data is missing, you will receive red error messages at the top of the screen. You need to fill out all mandatory fields, and then again click the Submit button at the bottom of the screen.
7. Complete these steps for the Contacts and Equipment tabs until all mandatory data is entered.
8. When you have completed entering data on the last tab, the annual review is complete. The system will direct you to your invoice.

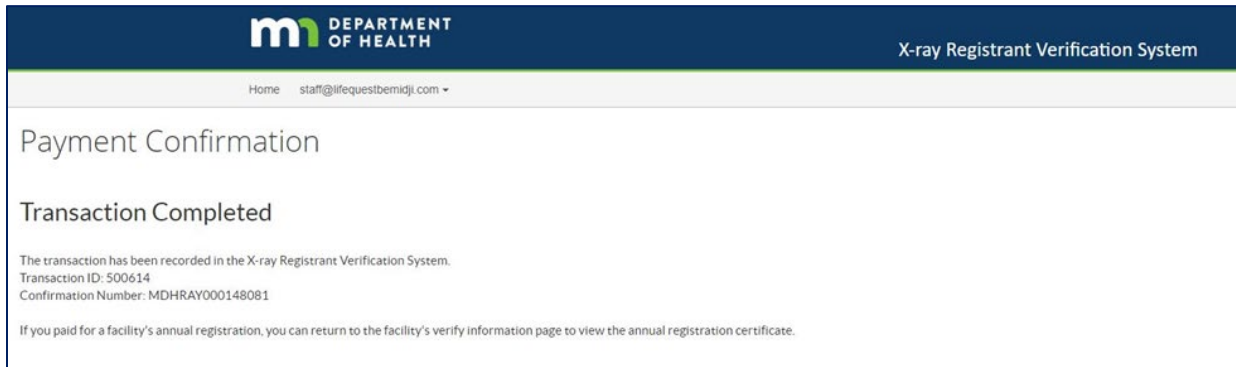
## Pay Invoice

After the review is complete or after you added new equipment, the system will direct you to your invoice. To make a payment, follow the steps below:

1. Verify the invoice is correct. If anything is incorrect, click on the Return to Home button to correct the data.
2. Click on Pay Now. You will be redirected to the US Bank Payment Portal.
3. Enter all the mandatory fields in the US Bank Payment Portal.
4. For credit card payments, there is a 2.49% service fee in addition to the invoice payment. There is no fee for e-check payments.
5. Click Confirm. You will receive a confirmation number.
6. Click Continue to finalize your payment in our system. If you do not click Continue, the invoice will not show as paid in the system.



7. After payment is complete, you will be redirected back to the online system.
8. You will receive a Payment Confirmation message in our online system.

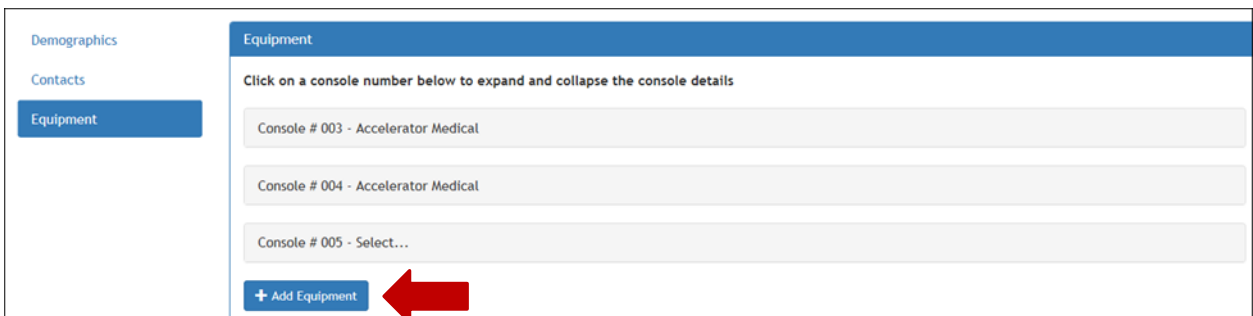


9. If you have submitted your Annual Registration, you can print or save your registration certificate by clicking on the Home button, then view. You will see the print certificate message on the top of the Demographics screen.
10. The X-ray Unit will receive record of your payment made.

## Adding New Equipment


Registrants with an Additional Registration can make payments through the online X-ray Registrant Verification System. New equipment can be added to the system, and the invoice can be paid at that time. To complete additional registration, follow the steps below:

1. Go to the Equipment tab.
2. Click on Add Equipment button. The new equipment will be added to the inventory list in sequential order.



3. Click on new equipment Console #. Enter all mandatory fields. 4. To submit equipment changes, the registrant must review the text in red at the bottom of the Equipment tab. It is mandatory to check the box before clicking on Submit Equipment Changes.



2. Find x-ray equipment being replaced.
3. Click on Console # and Replace Console button.
