

MLS Laboratory Update: MDH Investigating Paraburkholderia fungorum

OCTOBER 1ST, 2024

Purpose of this Message:

To request that MLS partners perform a 12-month look back for any *Paraburkholderia* fungorum or *Paraburkholderia* sp. that they may have identified in their laboratories.

Action Item:

Please perform a 12-month look-back in your microbiology laboratory data to find any *Paraburkholderia fungorum* or *Paraburkholderia* sp. isolates that may have been identified by your laboratory and reply to this email if you have detected this organism. Please provide a contact for MDH to call back to collect more information.

Background:

MDH is investigating an increase in submitted isolates identified as *Paraburkholderia fungorum* or *Paraburkholderia* sp. MDH is aware of 15 *P. fungorum* or *Paraburkholderia* sp. that have been isolated in Minnesota since September 2023. Seven of the isolates were initially submitted to MDH-PHL to rule out *Burkholderia mallei* and *Burkholderia pseudomallei* and subsequently identified as *Parabukholderia fungorum* at MDH-PHL by 16S ribosomal DNA sequencing. All were detected in blood cultures from patients where medical record reviews indicate that they may not have had true infection with the organism. Prior to 2023, *P. fungorum* had only been identified once at MDH-PHL.

Paraburkholderia were split from the Burkholderia genera in 2016. Paraburkholderia is associated primarily with environmental species, while Burkholderia are typically species clinically relevant to humans.

If your laboratory has identified *P. fungorum* or *Paraburkholderia* sp. in the last year, please reply to this email. We will respond to gather additional information about collection date, source, etc.
