The quarterly session of Coffee with the Coordinators was held on January 24th. This is an interactive conversation, including sharing of templates and resources among colleagues.

Thirty Trauma Program Managers and Trauma Medical Directors from 25 hospitals were in attendance. Topics included Level 3 tools and resources, educational opportunities, performance improvement processes including case finding and standards of care for chart review, Trauma Team Activation (TTA) criteria, team engagement strategies, and tertiary committee meeting minutes.
