The Northeastern Regional Trauma Advisory Committee (NERTAC) rolled out a new protocol for all patient hand offs. The new "DMIST protocol" reflects current best practices between pre-hospital and hospital providers. Demographics- Name, date of birth, age, sex

Mechanism/Medical Complaint- Time, mechanism of injury or medical complaint/history

Injury/Illness- list of injuries head to toe, assessment findings, STEMI/Stroke/Sepsis/Trauma criteria, Pain

Symptoms & vital signs- vital signs, first set and significant changes, GCS



Treatments- treatments/interventions given, patient response

Trauma Program 101 Course

- Understand the trauma system designation criteria as an overview of the trauma program

- Learn basic trauma performance improvement (PI) concepts
- Access educational and networking opportunities for continuous growth of your trauma program

The next Trauma Program 101 Course will be on Thursday, **April 3, 2025** in St. Cloud. Registration is not yet open for this offering.
